OUR HERITAGE

The Children's Charities Association of Singapore (CCA) began as an unstructured group of charities benefitting children. The charities got together to organise joint fundraising projects in the 1960s.

The success of the first Christmas Fair organised in 1965 at the Victoria Memorial Hall drove home the need for a formal organisation.

In 1966, the Association was inaugurated through the untiring efforts of the late Mr. Francis Thomas who became the founding Chairman. It was subsequently registered by the Registrar of Societies and granted the status of an Institution of Public Character in 1972.

We are the co-ordinating body purposed to raise awareness of the needs of member charities, and organise fundraising projects for member charities, which have the common objective of helping physically, mentally and socially disadvantaged children of Singapore.

The original four member charities are:

Singapore Children's Society
The Singapore Association for the Deaf
Cerebral Palsy Alliance Singapore
Movement for the Intellectually Disabled of Singapore - effective 1st April 2023 is known "MINDSG Ltd.".

St. Andrew's Mission Hospital - the fifth member charity to join in 1971. **Association for Persons with Special Needs** – *effective* 1st *April* 2021 *is known as* "APSN Ltd."- the sixth member charity to join in 1977.

Our efforts are not only directed at alleviating the disablement of children but also at giving them hope for the future.

Our member charities are single minded in their efforts to educate, train and assist the children under their care to become independent and useful citizens who can play their role in the nation.

CHAIRMAN'S REPORT 2022-2023



On behalf of the Board of Directors, I am pleased to present the 57th Annual Report of The Children's Charities Association of Singapore (CCA) for Financial Year 2022/ 2023.

Financial Year 2022/2023 marked the gradual reopening of in-person meetings and events following improvement in the COVID-19 pandemic situation. We look forward to holding our future events in-person to showcase the good work done by our six member charities and raise the profile of CCA.

1. Fundraising

CCA's fund raising activities were carried out, both on the online platform as well as through direct appeals, to reach the public. Total amount raised from the 3 projects was \$20,023.60.

The Donation Draw project was not held for this financial year as CCA is in the process of digitalising the process of selling the tickets online as well as the hybrid way.

Through the generosity of donors, volunteers and supporters for on-going appeals and unsolicited funds, CCA received a total of \$478,930.00. Total income raised for financial year 2022 / 2023 was \$501,517.00.

2. Annual Distribution of Funds – 2021 / 2022

Cheques totalling \$570,000.00 were post mailed to the 6 member charities.

3. Future Plans & Commitment

CCA will continue to organize the four major fundraising projects to raise funds for the children under the care of the six member charities.

CCA will continue to partner individuals and organizations to coordinate events to raise funds and to raise awareness of the member charities' services to the children-in-need.

Singapore Children's Society

Singapore Children's Society protects and nurtures children and youth of all races and religions. In 2022, the Society reached out to 21,559 children, youth and families in need. Established in 1952, its services have evolved to meet the changing needs of children. Today, Children's Society operates 11 service centres island wide, offering services in the four categories of:

Vulnerable Children and Youth

We provide fundamental care and guidance for children and youth who are abused and/or severely neglected. Where suitable, with each child's best interests at heart, we collaborate with families to provide safe, stable and permanent care.

Family Services

We support and strengthen families in need by working together with them.

Highlights of 2022

2022 was Singapore Children's Society's 70th Anniversary and we celebrated the occasion through various events.

1. Sunbeam Place @ Children's Society Talent Show

Given the significance of Sunbeam Place, it was especially fitting to have the Home's annual talent show kickstart our anniversary celebrations on 16 April.

Sunbeam Place began as the Convalescent Home in 1956, providing shelter, comfort and relief to children during the post-war years. It was a place for malnourished children to recuperate until they were strong enough to go home. The Home evolved to provide care for abused and severely neglected children as societal needs changed. In 2006, the Home took on a new name, Sunbeam Place.,



During the Talent Show, Guest of Honour, President Halimah Yacob, and other guests were treated to a display of the residents' talents and a sharing from an alumnus on his stay at Sunbeam Place. There was also a special cake cutting ceremony to mark the

Society's official birthday, which falls on 17 April. Besides the talent show performances, the event also featured a heritage exhibition and a home tour, in which residents showcased their work and the Home's significant milestones over the years.

2. Singapore Children's Society Awards 2022

On 28 May, we had our annual Singapore Children's Society Awards presentation, where we paid tribute to our volunteers and donors for their commitment and contributions. 60 individuals and corporates were honoured at the awards presentation, graced by Guest of Honour, President Halimah Yacob.



3. Yishun Family Service @ Children's Society Open House

Yishun Family Service @ Children's Society marked 27 years of commitment to Yishun residents with an Open House from 9 July to 30 September. The Open House showcased the centre's services and programmes, as well as personal stories of beneficiaries, volunteers and staff — especially how they navigated challenges brought about by the COVID-19 pandemic. Guest of Honour, Mr Derrick Goh, MP for Nee Soon GRC, launched the Open House on 9 July.

Children and Youth Services

We provide value-adding care, nurture and inspire children and youth, to complement what their parents and guardians provide.

Research and Advocacy

We perform research and advocacy work to protect and promote the well-being of children, youth and their families, as well as to enhance the usefulness of social services to children and youth.

4. 70th Anniversary Learning Festival

A Learning Festival was held on 14 October with over 300 attendees. It comprised three learning sessions, our flagship Children's Society Lecture and a book launch.

In the first session, "Vulnerable Children's Journey Home", panellists discussed the challenges of reunifying children in out-of-home care with their birth families. The second session, "Children's Mental Health: Beyond Awareness", tackled the mental well-

being of our children while the final session "Physical Discipline in Families: Can We Spare the Rod?" spotlighted a joint research study by the Society and Yale-NUS College on the use of physical discipline by Singapore parents.

Wrapping up the day of learning was the launch of "Thinking of Children: The Singapore Children's Society Collected Lectures (2015-2021)", the second book in our series of collected lectures by distinguished speakers on subject matters relating to children.

5. 70th Anniversary Charity Gala Dinner

Being the Society's first Charity Gala Dinner since the pandemic, around 320 guests attended the dinner at the Sands and Expo Convention Centre on 22 November, where Deputy Prime Minister Heng Swee Keat was the Guest of Honour. It was a highly successful fundraising event as we managed to raise a record \$1.4 million. In celebration of our 70th Anniversary, we published a commemorative book entitled 'By Your Side: 70 Years of Journeying Together'. This book describes the Society's work since our inception, focusing on our work in the last ten years. The first copy of this publication was presented during the Charity Gala Dinner to the Guest of Honour.

THE SINGAPORE ASSOCIATION FOR THE DEAF

The Singapore Association for the Deaf (SADeaf) has been serving the Deaf and Hard-of-hearing community in Singapore for the past sixty-six years. Established in 1955, it now serves more than 6,500 Deaf and Hard-of-hearing persons and provides a gamut of services such as sign language interpretation, note-taking, Deaf awareness workshops, employment support, counseling and financial assistance, and recreational activities.

SADeaf is a member of the National Council of Social Service (NCSS), and also supported by Community Chest of Singapore, Ministry of Social and Family Development (MSF) and Ministry of Education (MOE). The association is also affiliated internationally, to the World Federation of the Deaf (WFD) and, locally, to The Children's Charities Association of Singapore (CCA). SADeaf's mission is to assist the Deaf and Hard-of- hearing to achieve a better quality of life and to enable them to integrate and contribute to society.

Mountbatten Vocational School

Mountbatten Vocational School (MVS) The school is an ITE Approved Training Center which caters to students with special needs from the ages of 14 to 21. MVS offers a two-year ITE Skills Certificate programme in Food and Beverage Service, Food Preparation, and Housekeeping Operations.

Deaf Education

In addition, SADeaf provides Specialised Teachers. Education Interpreters and Resource Teachers to the Mayflower Primary School and Beatty Secondary School respectively to support the Deaf and Hard-of-hearing students in the mainstream school. The association has also started a communication and language programme for children with hearing loss below seven years old (Little Hands Bilingual-Bicultural Programme).

About Cerebral Palsy Alliance Singapore:

Cerebral Palsy Alliance Singapore (CPAS) is a social service agency established in 1957. CPAS provides persons with cerebral palsy and multiple disabilities with early intervention, special education, rehabilitation services, day activity centre programmes as well as vocational training and gainful employment in Singapore.

Through active advocacy and the support of equal opportunities for all persons with cerebral palsy and multiple disabilities, CPAS hopes to empower these individuals by helping them realise their full potential and lead fulfilled, dignified lives. Driven by our core values of hope, empowerment, aspiration, respect and trust, the organisation is focused on delivering fully integrated programmes and services at the highest standards. At present, we look after over 700 clients ranging in age from a few months to 55 years old.

CPAS is a registered charity with Institution of Public Character (IPC) status and is a member of the National Council of Social Service.

Our Programmes:

Early Intervention Programme for Infants and Children (EIPIC)

For children up to 6 years old

EIPIC provides early intervention for children with identified needs between the ages of a few months to six years old. A Trans-Disciplinary Approach is integrated into the curriculum. A multi-disciplinary team collaborates with caregivers to provide holistic education and support to help each child maximise his or her developmental growth.

CPAS School (CPASS)

For children between 7 and 18 years old

CPAS School is a double-session Special Education (SPED) school serving students with moderate to severe multiple disabilities. We offer the SPED Curriculum as recommended by the Ministry of Education. Through our mission of equipping our students with a holistic education to live meaningfully, learn continuously and work productively, they learn and develop in six domains. For selected students with good motor and functional skills, their curriculum includes pre-vocational training.

Adult Services (For adults 18 years old and above)

Goodwill, Rehabilitation, and Occupational Workshop (GROW)

GROW is a sheltered workshop that provides vocational training and sheltered employment through various projects. GROW provides an environment for self- development, and nurtures skills for community integration.



Day Activity Centre (DAC)

DAC provides day care for persons who require higher support. The primary aim is to nurture self-help skills through a balanced and structured curriculum of daily living, social skills training, therapy rehabilitation care and recreational activities.

CPAS Connect Alumni Programme

CPAS Connect is an alumni programme that engages former students and clients through social activities and sports.

MINDSG LTD (MINDS)

MINDS has been caring for Persons with Intellectual Disability (PWIDs) and their families since 1962. Being one of the largest charities in Singapore today employing more than 900 staff, the agency serves close to 5,000 PWIDs and their families every year. MINDS offers a holistic range of services across the PWIDs' lifespan, with the aim of empowering them and enhancing their quality of life. These include schools, employment and training development centres, home-based care services and community-based services to cater to the physical, psychological, environmental, and social needs of PWIDs. MINDS Children's Wing – Singapore's First Home for Children with Intellectual Disability

Children's Wing at MINDSVille@Napiri is Singapore's first home dedicated to house children with intellectual disability from 6 to 18 years old. These children are typically from families who are unable to provide them with adequate care and CCA's funding goes towards supporting Children's Wing to run programmes aimed at helping the children re-integrate with their families.

Providing a Better Learning Environment for the Children

Early intervention is critical for children with special needs. Every child is assessed upon their admission into Children's Wing and an individual care plan (ICP) is then drawn up and implemented, including any family intervention that may be required to better support the child.



The ICP details the needs of the child and identifies the areas for improvement. MINDS then provides guidance to equip the child with the necessary skills e.g. Activities for Daily Living skills, home living skills and social skills to enhance their quality of life.

While the ICP focuses on the child, family support is equally important so that the intervention and training is consistent and continues even when the child is on home leave. The ICP is also reviewed every six months to ensure that the interventions remain relevant with targeted outcomes to benefit the child.

Children's Wing offers a range of programmes aimed at creating stimulating and meaningful learning environment for the children. These include programmes like music and movement, arts and crafts, learning day, and sports day. There are also special programmes such as travelling day, ones that hone their skills in Community Living and home management, as well as the Snozelen Room Programme, where we utilise multi-sensory equipment to create a relaxing environment to enhance the sensory abilities of children who require sensory training. Children at Children's Wing also receive counselling and therapy services to improve their social and communication abilities.

Community Living Skills

AT MINDS, we also strive to develop the community living skills of our children. This includes crossing the road and taking public transportation, shopping and making choices in restaurants. Children's Wing also adapts its programmes to cater to the different learning needs and abilities of the children, providing visual aids and designing simple activities to facilitate their learning.

Children with intellectual disability also have different speech and communication abilities. Hence, Key Word Sign is widely used in Children's Wing and the children are taught to use a combination of gestures, body language and speech to support their communication with one another.

Home Management

The Home Management programme is designed to help the children develop basic life skills including self-care, meal preparation, organising and keeping their rooms clean, bed making, helping with chores, etc. These skills are learned over time, beginning at home at a very young age and reinforced throughout adulthood. Children with disabilities often require additional support when learning life

skills. Their ability to participate in home management activities will help boost their confidence in their ability to function independently and take care of themselves.



Travelling Day

Travelling Day is a great opportunity for our children to learn how to adapt to the environment, step out of their comfort zone to try new things and gain new experiences. Through various activities, the children also learn to be independent and to interact with the community, an important step in the process of helping them reintegrate with their families.



ST. ANDREW'S MISSION HOSPITAL

In 2022, St. Andrew's Mission Hospital (SAMH) continued to navigate uncertainties brought on by the COVID-19 pandemic and emerged stronger and ever ready to serve those in need. And autism is one of the SAMH's core pillars of service

St. Andrew's Autism School (SAAS) - Into its 17th year of service

SAAS has been caring for children and young people with moderate to severe autism for 17 years. It is colocated with the St. Andrew's Adult Autism Service (post-18 programme) at Elliot Road. It continues to enhance processes to deepen care for its students and their families and caregivers, for its conviction that no one with autism should journey alone.

SAAS remained focus on building universal systems and processes of support for students, many of whom have complex needs, so as to provide clarity in the work that teachers do. In tandem with the service wide PBS approach, teachers learnt about the students' strength, interest, preferences and needs and put together the individual profile of all students. The case management and referral processes were reviewed to enable the students and their families to receive timely intervention and support.

SAAC's Allied Health professionals were instrumental in supporting frontline staff through providing case management guidance. These included reviewing and improving case management processes, staff training in key interventions, working with parents to ensure smooth transition of learning from school to the home environment. Specifically,

the occupational therapy team prioritised their services to support students with complex behaviour and sensory issues.

St. Andrew's Mission School (SAMS) - Our second SPED School

In 2022, St. Andrew's Mission Hospital's (SAMH) established SAMS, its second special education (SPED) school for children on the autism spectrum who are able to access the national curriculum. The school received its first cohort of Primary One Students on 17 January at its campus in Bukit Batok.

In building a caring culture where staff can synergise to serve and soar, SAMS embarked on the professional development of its staff drawing from experts in the field both within Singapore and abroad at Australia in which the Principal and a team of Allied Professionals visited ASPECT in Sydney. A series of online workshops was also launched for the teachers. Equipping the staff with knowledge and skills on Positive Behaviour (PBS) and Zones Support of Regulation, SAMS aims to provide the best support for students' social emotional learning.

To deepen and augment the pedagogical skills of our teachers to deliver the national curriculum, former Master Teachers from the MOE were engaged to train and mentor the teachers in the teaching of English and Mathematics. The teachers also leveraged on OPAL 2.0, MOE online professional an development platform, to grow professionally.

In addition, regular engagement with parents was maintained through chat groups, Qoqolo (a parent student portal) and Parent-Child-Teacher-Conference (PCTC) sessions to provide them with better support.

SAMH community stood as one, committing ourselves to the holistic education of students on the autism spectrum disorder to enable them and their families to live dreams through education pathways that are relevant, based on each child's natural abilities, aptitudes and gifting. This is the bedrock of SAMH education philosophy - that all children are precious and special, and to be loved and treasured.



SAMS celebrated its first Children's Day Carnival



Occupational Therapist (OT) provided a pullout intervention service to engage with one of our students at SAAS. This helped him to process sensory information that facilitated regulation and engagement. In addition to providing targeted intervention for clients, students and residents, the OTs also help to facilitate functional daily living skills of persons with autism in areas such as selfcare, lifeskills, work and leisure.

APSN LTD

About APSN

Established in 1976, APSN is a social service agency that provides special education, vocational training and employment support services for individuals with mild intellectual disability (MID) – i.e., IQ ranges between 50 and 70.

APSN Schools and Centres adopt a holistic approach in their curriculum, comprising academic, vocational and social skills, which are important for open employment and lifelong learning. APSN seeks to enable persons with special needs to be active contributors of society and is committed to inspire and build capabilities of its partners and community to lead and advocate towards an inclusive society. Currently, APSN cares for more than 6,000 beneficiaries, students, trainees and alumni. APSN is also constantly expanding its network to reach out to and understand the needs of its members to better support them.

APSN's activities are carried out by two incorporated companies limited by guarantee – APSN Education Services Ltd and APSN Ltd. APSN Education Services Ltd oversees the operations of four APSN Special Education (SPED) Schools while APSN Ltd. manages the APSN Centre for Adults, APSN Student Care Centre, and APSN Learning Hub. Both entities work seamlessly together as One APSN to provide holistic education, training, employment assistance, as well as continuing support to all APSN beneficiaries through the different stages of their life journey.

APSN SPED Schools and Student Care Centre



APSN Chaoyang School specialises in providing quality primary school education to children with MID between 7 and 12 years old. APSN Katong School is the only APSN school that offers a complete suite of primary and secondary education, catering to students with special needs aged 7 to 16 years old. APSN Tanglin School caters to secondary school students with MID between 13 and 16 years old. APSN Delta Senior School is a post-secondary vocational special education school that prepares students for open employment. APSN Student Care is a before-and-after-school-care service which is available for all school-going students with special needs aged 7 to 18 years old.

APSN Centre for Adults



APSN Centre for Adults is a sheltered workshop which provides vocational training, employment support services, allied professional and alumni services for individuals with mild intellectual disability, aged 18 and above. We aim to provide autonomy to our trainees with special needs by allowing them to experience a variety of job industries such as Food & Beverage

Service, Kitchen, and Bakery), Horticulture, and Retail, before they decide on a career path that they would like to pursue. The centre also supports our alumni members should they need help at any point of time in life

APSN Learning Hub



APSN Learning Hub provides courses in the areas of disability, mental health and wellness, and social inclusion, and aims to develop the knowledge and capabilities of various stakeholders in the community so that we can strive towards a more inclusive society.

APSN Learning Hub is also working towards becoming an Accredited Training Organisation (ATO) and converting their courses into Workforce Skills Qualifications (WSQ) courses by 2024. As an ATO, APSN will be able to provide value-added training by offering WSQ and non-WSQ courses to caregivers, employers, partners, volunteers and other professionals in the disability sector.

APSN Charity Fashion Party



In our first-ever APSN Charity Fashion Party, our trainees with mild intellectual disability from APSN Centre for Adults, partnered with the design team from TaF.tc to co-design an exclusive range of outfits. It was our first physical fundraising event since the pandemic and the event was graced by President Halimah Yacob on 11 January 2023.
